# New Dollar General in the 776

Construction on a new Dollar General store is underway next to Illinois Route 336, near West Prairie Middle School. Bob Elkan, president of Westmore Group, Inc. of Chesterfield, Mo., says the building should be completed by late July. In addition to regular Dollar General merchandise, about 25 percent of the 9,026 square foot building will be devoted to grocery items, including frozen foods.

Elkan said Illinois Route 336 was a major influence in selecting a location. He projects the store will do well, drawing customers from 15-20 minutes away.

The store will closely resemble the LaHarpe Dollar General, which

was also built by Westmore Group, Inc.

Emily Wisse, media relations manager at Dollar General, said demographics, traffic patterns, and customer needs made Colchester an ideal store location.

The store's goal is to be a convenient shopping choice for customers in a three- to five-mile radius. Wisse said the store will employ six to 10 people. Anyone interested in applying may obtain an application in the store after opening. She also said the Colchester store's hours and grand opening date are still being determined. Dollar General operates over 9,000 stores across 35 states.

According to a map Heerboth presented to the West Prairie School Board, the proposed TIF district could encompass a wide swath of Colchester, including commercial, institutional, residential and undeveloped property, that is considered to be "blighted," or to have stagnant property value.

Heerboth said that while he supports the Colchester City Council in its effort to boost economic development, he hopes those representing West Prairie School District will have a seat at the table as the TIF discussions continue. "It's very difficult to see how we can come out ahead," Heerboth said of the TIF district, but he gave the West Prairie Board some of his projec-

tions about the potential

impact. Under the Colchester City Council's plan for a TIF district, West Prairie will receive, up through 2034, property tax revenues from the TIF district the amount of in \$213,934.63 per year - the revenue received in 2011 - even as the EAV increases from the present \$4.3 million to a potential \$16.3 million 23 years down the road as the TIF district becomes developed.
